Mon State Government Fails Follow-up Reporting to Hluttaw on Rules, Regulations and Orders of the Laws Promulgated

June 5, 2017

Although the [Mon] State government has been implementing the enacted laws, the relevant government departments fail to send related rules regulations and orders of the promulgated laws to State Huttaw for its review and record, in both current and previous terms, according to the Deputy Speaker of Mon State Hluttaw.

Dr. Aung Naing Oo, the Deputy Speaker of Mon State Hluttaw, raised the question at a recent Hluttaw meeting as the State government of both terms failed to do reporting to Hluttaw on follow-up rules, regulations and or-



ders of promulgated laws in both Hluttaw terms- the first Hluttaw of 2010 to 2015, and up to the recent sessions held on June 8 of the current Hluttaw took its term in 2016.

"We have not witnessed submission, with detail explanations, of any rules,

regulations and orders of all the laws approved by the State Hluttaw and bylaws are issued. Thus, we need to know if relevant rules, regulations and orders are not prepared or why these documents are being failed to be submitted and explained well at the State Hluttaw," recently asked Dr. Aung Naing Oo at a regular meeting of State Hluttaw.

Dr. Aung Naing Oo stated that Article 60 (A) and (B) of the Constitution, and the Article (60) of the State Hluttaw Law required the State government and respective governments to submit bylaws, rules, regulations, orders and procedures to State Hluttaw.

"Companies Implementing Projects to be Prepared to Meet Standards", Warned by Magway Hluttaw

June 5, 2017

Meeting with implementing companies for 2016-207 fiscal year was held at Magway Region Hluttaw Conference Hall on 5 June. Hluttaw Speaker, Deputy Speaker, Ministers and Officers of the regional government, Member of Hluttaws, the Head of Hluttaw Office and representatives from implementing companies attended the meeting and discussed.

During the meeting, the Hluttaw speaker stated that the regional hluttaw was informed by the quality examination group that some companies' works are not meeting the standards and showed poor quality, assumed they are making undue profits. Continuously, he warned that these poor quality work will not be accepted and to do properly again, and if the companies which will not correct themselves in a given time and if poor quality will be



found again, these companies will be black listed. After a given time-frame for correction, MPs will check again the work in respective townships, and thus, he warned companies to implement

their projects well to avoid to be listed as disqualified company. The Speakers, the government departments and the companies also did detailed discussion at the meeting.

Tatmadaw Representative Questions for the First Time at 2nd Mon State Hluttaw

June 8, 2017

It is for the first time that the Mon State's Minister of Security and Border Affairs, as a Tatmadaw representative, submitted the question the meeting of Second Hluttaw of Mon State on June 7.

Colonel Win Naing Oo, the Minister of Mon State's Security and Border Affairs asked question whether there is a plan for imposing effective (proper) sentences, pointing out incidences of appeals to the courts for increasing penalties to be proper and suitable ones. U Khin Maung Gyi, the State Chief Justice answered that from 2015 to April 2017, there are 130 cases confirmed out of 180, which were appealed for increased sentences, and in 15 cases, sentences were increased, while some are still proceeding.

Chin Hluttaw discussed Eradication of Thousands of Poppy Fields in Tonzang Town

June 8, 2017

Chin State Hluttaw Representative Thawng Khu Mang stated that thousands of acres of opium plantations are grown in Tonzang Township of the Chin State due to difficult road access.

He raised the question of eradication of opium plantations at Hluttaw in 18 May this year and official simply answered that relevant government [departments] destroyed the opium crops every year. The official explained that the opium cultivation is quickly spread out as the road access in the township is very difficult and groups are not able to reach to these areas to destroy the plantations.

He said that it's estimated that over a thousand acres are being cultivated every year, and both state government and union government should have a detail plan of demolishing poppy plantations throughout the township.

"It is not that they are poor to depend on opium farming. But, they grow it as they want to earn easy money. In the past, the ancestors did cultivating on hills, and they worked really hard for living. These days people work less but want to gain more," said Thawng Khu Mang.

According to Falam District Police Office, about 566.81 acres of poppy plantation was destroyed in 2014, in Cikha Sub-township of Tonzang Township, Falam District, located in northern Chin State, while within two months of December and January 2015 alone, 876 acres of poppy plantations were eradicated. Tanintharyi Electricity Issue to be Heard at Hluttaw

June 7, 2017

Electricity in Tanintharyi Region, which is being interested by people and communities in Tanintharyi, will be discussed by conducting a hearing session at Tanintharyi Region Hluttaw from 5 to 7 June, according to officials of Tanintharyi Region Hluttaw Office.

[Tanintharyi] Region Hluttaw Speaker U Khin Maung Aye said that a hearing event is to be held to explain to the public with more information on how the region government has been handling the issue and what are coming plans.

"The electricity issue becomes a

wide spread topic among the public. It is necessary for more and clear information for the public. The MPs can also question what they want to know," said U Khin Maung Aye.

He said that Region-level officials, the representatives from Hluttaw committees, and MPs, but [not] respective electric power ministers will attend the hearing event, and the Minister of Electricity will not be able to attend. The outside observers won't be allowed to participate in the event.

Dr. Win Htein, who always writes articles about the Tanintharyi electricity issues said that MPs should raise questions on the long-term plan of access to

electricity in the region. He also pointed out uncertainty of different other sources of electricity such as hydro, solar and gas than diesel and finally communities cannot avoid the circle of diesel (depends only on diesel). In Tanintharyi Region, one unit of electricity is currently paid about 300 Kyat to 700 Kyat. The line distributed and generated by Dawei natural gas station is overloaded and often interrupted due to over consumption.

The hearing on education issue will also take place, after discussion on the electricity issue, though what issues will be discussed was still unknown.
